

PRODUCT DESCRIPTION

2. ANTIGEN DETAILS

Large description: Human CDIIc (alpha X integrin) complexes with CDI8 (beta2 integrin) to form the complement receptor type 4 (CR4) heterodimer which binds to fibrinogen and is involved with monocyte/granulocyte adhesion during inflammatory responses. CDIIc expression is restricted to leukocytes mainly of myeloid lineage with highest expression on macrophages.^(i,4)
