Immunogen: The anti-CD20 monoclonal antibody derives from human 6.16c1.3 B cell line;

Storage instruction: store in the dark at 2-8 °C;

2. ANTIGEN DETAILS

Large description: The reactivity of 2H7 MoAb has a bit wide including some dendritic cells, endothelial cells on vessels epithelial cells, some macrophages and some activated T cells. CD20 antigen is present on 8-16% of normal peripheral blood lymphocytes. CD20 MoAb recognizes type III unglycosylated phosphoprotein which crosses the cell membrane four times called TM4.⁽¹⁻³⁾
