
Anti-Human CD45RA (RP1/11)





1. PRODUCT DESCRIPTION

Clone: RP1/11;

Isotype: Mouse IgG1;

Tested application: flow cytometry;

Immunogen: The anti-CD45RA monoclonal antibody derives from immunizing mice with purified human CD45;

Species reactivity: Human;

Storage instruction: store in the dark at 2-8 °C;

Storage buffer: aqueous buffered solution containing protein stabilizer and 0.09% sodium azide (NaN_x);

Recommended usage: Immunostep's CD45RA, clone RPI/II is a monoclonal antibody intended for the identification and enumeration of helper/inducer T-cell subset and CD45RA+ cells using flow cytometry. This reagent is effective for direct immunofluorescence staining of human tissue for flow cytometric analysis using 1 test for IO6 cells;

Source: Supernatant proceeding from an in vitro cell culture of a cell hybridoma;

Purification: Affinity chromatography;

2. ANTIGEN DETAILS

Large description: The RPI/II monoclonal antibody reacts with human CD45RA, a 220 kDa molecule expressed by subpopulations of CD4+ peripheral T lymphocytes, CD8+ peripheral T lymphocytes, and B cells. The CD45RA+ T cell populations are mainly naive/virgin allowing the use of RPI/II mAb as a phenotypic marker to discriminate T cell subsets. $^{[1-6]}$
