■ Direct Immunofluorescence Cell Surface Staining Protocol

- Transfer 100 ul (106 cells/test) of the sample to a 12 x 75 mm polystyrene test tube .
- Add the suggested volume indicated on the antibody vial to the 12x75 mm cytometer tube.
- 3. Mix well and incubate in the dark at room temperature at 4 $^{\circ}$ C for 30 minutes or at room temperature (20-25 $^{\circ}$ C) for 15 minutes.
- 4. After the incubation period, add 1,5 ml of an erythrocyte-lysing solution and mix. Incubate at room temperature in the darkness (the blood should be well mixed with the lysing solution).
